

#### **About the Client**

The Philadelphia Activities Fund, Inc. (PAF) is a Pennsylvania non-profit organization, designated as a 501(c)(3) charitable entity. PAF's mission is to provide financial support to organizations and associations engaged in

recreational and community-based programs within the City of Philadelphia. By promoting sportsmanship, the arts, and health, PAF aims to enrich the educational and recreational landscape of the city. The fund offers grants to a diverse range of community and recreation organizations, fostering increased involvement and participation across various activities such as sports, dance, arts, and health initiatives. The fund awards approximately 1000 grants per fiscal year, this year totaling \$3.8M.

#### **Project Scope & Approach**

Anavi Strategies was brought on as a partner to revise and strengthen PAF's grant program policies and procedures to address organizational shifts and process gaps occuring within the organization over the past 4 years since the COVID-19 pandemic. We undertook a comprehensive assessment to



pinpoint areas for improvement and implemented streamlined processes to ensure smooth and effective grant cycles.

Our role as partners includes designing the grant application using the Submittable grant management platform. This encompasses creating an eligibility questionnaire, application forms, email templates, and grant contracts. In our first cycle as grant managers, we facilitated the board's procurement of the Submittable platform. Our role is to manage the entire grant program, ensuring compliance with program regulations and bylaws while delivering exceptional customer service to applicants, grantees, Councilmembers, and PAF stakeholders. We employ a trauma-informed and empathetic approach, ensuring every aspect of our work is executed with excellence and responsiveness to community needs.

#### **Project Activities**

Communication with City Council Staff	Regularly engage with council staff from all 10 districts to ensure seamless collaboration and support throughout the grant process.
Applicant and Grantee Support	Provide ongoing communication and problem-solving assistance to both applicants and grantees, ensuring their needs are met promptly and effectively.
Application Vetting	Thoroughly vet all applications to ensure compliance with grant eligibility criteria.
Weekly Check-Ins	Hold weekly meetings with the Submittable team to ensure the grant management platform is functioning optimally and addressing any issues promptly.
Quarterly Board Meetings	Conduct quarterly meetings with the PAF Board of Directors to align on procedures, provide program updates, and request special approvals for applications and budgets.
Budget Reconciliation	Meet with PAF's Controller on a monthly basis to ensure we maintain the financial health and integrity of the organization. In partnership with the Controller, we prepare the organization's budget and monthly financial reports for the Board of Directors, and maintain internal controls to safeguard the Fund's assets and ensure financial integrity.
Legal Counsel Management	Engage weekly or bi-weekly with PAF's legal counsel to review grant agreements and service contracts, establish and maintain governance best practices, ensure the organization is operating within the bounds of the law for compliance and regulatory issues, and to effectively fulfill the mission of the Fund.
Non-profit Administration	In addition to grant management and execution, Anavi Strategies ensures the Philadelphia Activities Fund is operating smoothly and efficiently. We ensure the Board of Directors has the information and resources they need to lead the organization. We coordinate policy development, compliance, vendor relationships, financial management, risk management, technology and information systems with an eye towards evaluation and improvement.

- **Applications Received:** Successfully managed **1,010 applications** for the 2024 grant cycle.
